BOMA Southwest Region Board of Directors Sunday, June 23, 2013 San Diego, CA

This meeting was called to order at 7:30am by President Tomi Sue Beecham.

A quorum was determined to be present.

Minutes of the previous meeting on March 22, 2013 were unanimously approved.

Secretary/Treasurer Melissa Graham presented the financial report, which was unanimously approved. The dues holiday will result in a net loss this year since there will be no income, however the bank account balance will easily absorb the loss.

All dues invoices which were outstanding have now been paid. Upon motion made by New Mexico and seconded by Greater Little Rock, the two locals which were suspended due to nonpayment, Northwest Arkansas and New Orleans, are returned to a status of good standing.

Lisa Hensley presented a report from the BOMA International nominating committee. She announced that the new slate of officers will be:

Scott Jones presented a report from BOMA International. They are working with a veterans' organization to promote jobs for vets. BOMA San Diego is celebrating its 50th anniversary. This year's trade show is larger than before. More young professionals are participating in BOMA. Industrial Day is being introduced, offering tours and education. A new asset management course will cover lease analysis, negotiation and approval. Just over 600 buildings have gone through the BOMA 360 process. BOMA's legislative efforts have saved over \$3.15 per square foot for owners. BOMAPAC has raised \$20,000 so far this year. The recent medical office building conference was the largest in its history.

The 2014 regional conference will be held in Fort Worth March 27-29. Tulsa will host 2015. 2016 remains unassigned. 2017 will be hosted by Northwest Arkansas.

The Bylaws Review Committee had its first conference call a few weeks ago. A Policies & Procedures document also needs to be developed. Drafts of these will be available for review by the next meeting date.

The Ferrell Hayes Scholarship will be funded for 2014. January 15 is the last date to apply.

The meeting was adjourned at 8:30am.
